This program also serves as a soft diplomacy tool to strengthen cooperation and friendship between partner nations through human resource development.

For the 2026 intake, the INSANI Scholarship at UIII offers Master's and Doctoral degree programs for civil servants, government officials, lecturers, and professionals from non-governmental organizations (NGOs), including individuals officially nominated by their respective governments. CHAPTER I

INTRODUCTION

A. BACKGROUND

The Universitas Islam Internasional Indonesia (UIII) was established based on Presidential Regulation (*Perpres*) No. 57 of 2016 concerning the Establishment of the Indonesian International Islamic University and has been in operation since 2021. UIII is an international-standard higher education institution and serves as a leading model for Islamic higher education in strategic Islamic studies under the Ministry of Religious Affairs.

UIII's primary mandate is to organize Master's and Doctoral programs within the Faculty of Islamic Studies, Faculty of Social Sciences, Faculty of Economics and Business, Faculty of Education, Faculty of Science and Technology, and Faculty of Law. UIII is envisioned to be at the forefront of research, where the output generated by faculty and students can serve as a global reference for the development of specific scientific fields.

Scholarships for students are a vital aspect of achieving the vision and mission of higher education. They are instrumental in fostering inclusive and equitable academic environments while supporting sustainable social and economic development. The INSANI Scholarship provides opportunities for citizens of registered countries to obtain an inclusive education, creating skilled, educated, and competent individuals who are expected to contribute to their nations' economic and social progress. Furthermore, the **INSANI Scholarship** supports innovation and research by enabling students to pursue advanced degrees, allowing them to engage in research and experimentation that may yield significant discoveries across various scientific disciplines.

B. OBJECTIVES AND SCOPE

The INSANI Scholarship is intended for foreign nationals (*WNA*) who meet the recipient criteria, with the following objectives:

1. To provide full educational financial assistance in the form of comprehensive scholarships to selected students.
2. To create opportunities for international students to obtain a proper and high-quality education.
3. To produce future intellectuals and researchers in their respective fields who can enhance their social roles within the international community.

The scope of the INSANI scholarship at UIII is extended to Non-Governmental Organization (NGO) employees, lecturers, or individuals officially recognized by their respective governments within the following study programs:

1. Faculty of Islamic Studies

- Master of Arts in Islamic Studies
- Master of Arts Specializing in Digital Islam
- Master of Arts in Turath Islam
- PhD in Islamic Studies

2. Faculty of Social Sciences

- Master of Arts in Political Science
- Master of Public Policy with concentrations in:
 - Climate Change
 - Climate-related Public Health
 - Climate-related Disaster Mitigation
- PhD in Political Science

3. Faculty of Economics and Business

- Master of Arts in Economics with concentrations in:
 - Islamic Banking & Finance
 - Muslim World Economy
 - Digital Economy & Data Science
 - Sustainability
 - Halal Industry & Policy Economics
- Master of Finance in Sustainable Finance
- PhD in Economics

4. Faculty of Education

- Master Arts in Education
- Master of Psychology
- Master of Educational Leadership
- PhD in Education

5. Faculty of Science and Technology

- Master of Science in Data Science

6. Faculty of Law

- Master of Laws

CHAPTER II

SCHOLARSHIP PROVISION

A. TARGET RECIPIENTS

The target recipients for the INSANI scholarship are foreign nationals from the following 17 countries: **Algeria, Azerbaijan, Bangladesh, Burkina Faso, Iran, Iraq, Libya, Maldives, Mauritania, Morocco, Mozambique, Palestine, Somalia, Sudan, Syria, Tunisia, and Yemen.**

B. REQUIREMENTS

The requirements for INSANI scholarship applicants are as follows:

1. Hold citizenship from one of the listed INSANI scholarship recipient countries.
2. Be willing to return and serve in their home country upon completion of studies.
3. Maintain civilian status (exempt from active military duty and mandatory military service obligations) throughout the end of the study period
4. For female applicants, be willing to declare that they are not pregnant at the time of the scholarship application.
5. Possess a valid passport with a minimum validity of 18 (eighteen) months from the date of registration.
6. Preference is given to those with a minimum of 2 (two) years of work experience as employees of NGOs, CSOs, or as Lecturers in their home country.
7. Provide an employment certificate from the government sector or an equivalent document.
8. Demonstrate English language proficiency according to the following provisions:
 - a. Applicants from non-English speaking countries are required to attach English proficiency certificate such as TOEFL ITP certificate with a minimum score of 500 or IELTS with a minimum score of 5.5 for the master's level, and a TOEFL ITP score of at least 530 or IELTS of at least 6.0 for the Doctoral level.
 - b. This requirement is waived for applicants from countries where English is the medium of instruction.
 - c. This requirement is also waived if the applicant is a graduate of a university that uses English as the medium of instruction or Arabic as the medium of instruction (specifically for M.A. in Turath Islam applicants).
9. Upload diplomas and academic transcripts legalized or officially recognized by the Ministry of Education and/or the Ministry of Foreign Affairs in the applicant's home country or country of residence.
10. Provide a valid Police Clearance Certificate (PCC) and/or an equivalent Criminal Record Certificate from the relevant local authorities.
11. Commit to undergoing a comprehensive medical check-up upon admission to the INSANI Program and provide a valid medical certificate from an authorized physician confirming physical and mental health.
12. Submit a Statement of Purpose detailing study objectives, the background of interest in studying in Indonesia (UIII), the proposed research topic, and future academic plans/Dissertation Proposal (**Doctoral applicants only**)

13. Doctoral candidates are required to conduct their **research in Indonesia**. If a doctoral student conducts research activities outside the territory of Indonesia, all expenses incurred shall be the responsibility of the respective student.
14. Provide a valid Unconditional Letter of Acceptance (LoA) from UIII
15. Applicants must apply for a degree level distinct from any previously attained. Master's applicants must not have prior Master's-level studies, and likewise for Doctoral applicants
16. Master's degree applicants are eligible up to the age of 37 (thirty-seven) as of July 31st of the application year.
17. Doctoral degree applicants are eligible up to the age of 43 (forty-three) as of July 31st of the application year.
18. Applicants must commit exclusively to the INSANI program and may not be enrolled in any other higher education institution simultaneously.
19. The INSANI scholarship shall serve as the sole source of funding. Awardees are not allowed to receive other scholarships or grants simultaneously.
20. Applicants must commit exclusively to the INSANI program; applying for or enrolling in double-degree programs is not permitted.
21. Recipients must remain unmarried for the duration of the scholarship. Should a recipient marry, their study visa will be revoked, and they must personally cover all visa and ITAS costs.
22. The scholarship is awarded for full-time study only within the designated program at UIII.
23. Recipients are required to attend classes consistently and maintain active participation until graduation.

C. SCHOLARSHIP SELECTION PROCESS

The INSANI scholarship selection process consists of three stages:

1. Administrative Selection

The administrative selection is the process of verifying the completeness and suitability of the documents required for registration. All uploaded documents must be in English, including:

- a. Certificate of graduation or diploma from previous studies
- b. Academic transcripts
- c. Personal Statement
- d. Curriculum Vitae (CV)
- e. Valid passport with a minimum validity of 18 months from the registration date
- f. Employment certificate or official document indicating employment status
- g. For non-government employees, an additional certificate from a competent authority stating that the applicant possesses the potential to work in local government after completing the program or specific study level
- h. Certificate of good conduct and/or a criminal record clearance issued by the authorized local authorities

- i. Medical certificate confirming the applicant is physically and mentally fit, issued by an authorized doctor
- j. Prospective scholarship recipients must include a Personal Statement as specified in the attached documents

2. Academic Selection

Academic selection consists of the following phases:

- a. **Desk Review** is an evaluation process conducted to assess candidates based on their academic eligibility documents.
- b. **Psychological Test** is conducted to measure the psychological aspects of an individual and their relation to intellectual capacity, interests, and talents within the field of education.
- c. **Interview** is a question-and-answer process conducted by university interviewers with the scholarship applicants to gather specific data or information to determine the applicant's eligibility for the scholarship.

3. Health Examination

All prospective INSANI Scholarship recipients must undergo a comprehensive medical and psychological examination, includes:

- a. **Mandatory Drug Test**, to ensure that prospective recipients are free from the use of illicit substances or prohibited drugs.
- b. **Mental Health Assessment**, to evaluate psychological readiness and emotional stability for undergoing academic studies abroad, as evidenced by a certificate from a psychiatrist.
- c. **Infectious Disease Screening**, including HIV/AIDS, Ebola, Yellow Fever, Meningitis, Tuberculosis (TBC), Zika, West Nile Fever, Hepatitis, and other sexually transmitted diseases, to ensure that the recipient does not pose a health risk to themselves or others during the study period.

CHAPTER III

DISBURSEMENT, WITHHOLDING, AND TERMINATION OF SCHOLARSHIP

A. GENERAL GUIDELINES FOR SCHOLARSHIP DISBURSEMENT

Scholarship components are disbursed directly to the scholarship recipient's *Mandiri* bank account. INSANI scholarship recipients may open an account by visiting the Office of Student Affairs and International Services at the UIII Rectorate Building. Appointments should be requested via email at io@uiii.ac.id or +62 822-9572-7244.

B. SCHOLARSHIP WITHHOLDING

The withholding of scholarship disbursements shall be applied for recipients under the following circumstances:

1. Doctoral students who return to their home country for more than 3 months for reasons other than research.
2. Master's students who return to their home country during the semester break.
3. Scholarship withholding is implemented if a student applies for a leave of absence.

If a student takes a leave of absence during the current semester or submits a leave application outside the academic calendar's designated period, they must refund all scholarship benefits received prior to the official approval of the leave for that semester.

C. SCHOLARSHIP DISBURSEMENT

Scholarship recipients who have previously taken a leave of absence (voluntary or mandatory) are eligible for the reinstatement of their scholarship funding, provided they fulfil the following requirements:

- a. **Status Reactivation:** Formally reactivate their student status and report to their respective Faculty in accordance with the current academic calendar.
- b. **Travel Documentation:** Attach a scanned copy of their passport showing the Indonesian entry stamp and/or valid proof of travel to Indonesia (e.g., flight ticket or boarding pass).
- c. **Arrival Validation:** Submit the official Arrival Form duly signed by the Head of the Study Program, as specified in Appendix 1.
- d. **Submission Procedure:** All aforementioned documents must be submitted via email to academic@uiii.ac.id with a copy (cc) to io@uiii.ac.id.

D. PERMANENT TERMINATION OF SCHOLARSHIP

Permanent termination of the scholarship shall be enacted under the following circumstances:

1. The student officially withdraws from the program or passes away.
2. The relevant Study Program or Faculty issues an official memorandum to the Directorate of Academic Administration requesting permanent termination of funding.
3. The scholarship recipient departs from the UIII campus and fails to return for a maximum period of 5 (five) consecutive weeks without prior notification or valid justification.

CHAPTER IV

ADDITIONAL PROVISIONS

A. RIGHTS OF INSANSI'S AWARDEE

1. Obtain official status as a recipient of the Indonesian AID Scholarship; and
2. Receive all rights in accordance with the prevailing provisions governing the Indonesian AID Scholarship.

B. OBLIGATIONS OF INSANI'S AWARDEE

INSANI's Awardee are required to comply with all applicable obligations, in terms of:

1. Attending and completing all academic activities in accordance with the academic regulations of UIII.
2. Behave in a professional and responsible manner and comply with all applicable laws and regulations of the Republic of Indonesia.
3. Returning and contributing to their home country upon completion of their study period.
4. Completing, signing, and complying with the provisions set out in the Personal Statement/Student Agreement; and
5. Comply with all terms, conditions, and regulatory provisions related to the Indonesian AID Scholarship, including those specified in the Personal Statement/Student Agreement.

C. CANCELLATION OF INSANI SCHOLARSHIP

The status of an INSANI's Awardee may be revoked for the following reasons:

1. Failure to complete the study program within the maximum period as determined.
2. Committing a criminal offense in violation of the laws and regulations of Indonesia during the study period.
3. Withdraws from the program for personal reasons; and
4. Failure to comply with the provisions related to the Indonesian AID Scholarship, including those stipulated in the Personal Statement/Student Agreement.

D. PENALTY

Penalty may be imposed on scholarship recipients for the following violations:

1. Falsification of documents.
2. Plagiarism.
3. Fraud; and/or
4. Violations of the provisions and regulations governing the Indonesian AID Scholarship, including those stipulated in the Personal Statement/Student Agreement.

The penalties that may be imposed include:

1. The INSANI's Awardee is declared in violation of the program regulations and is no longer eligible to receive any grants or scholarships from Indonesian AID in the future.
2. Exclusion of a university or government training institution from participation in the Indonesian AID Scholarship Program for a period of two (2) years or until a decision is issued by the Ministry of Higher Education, Science, and Technology and **Indonesian AID**.

E. FORCE MAJEURE

Force majeure refers to emergency situations and/or specific circumstances that prevent an international student from continuing his or her studies, including:

1. The official declaration of death of the INSANI's Awardee.
2. INSANI's Awardee suffering from a serious illness not covered by insurance, which prevents the continuation of studies, or experiencing health or mental health conditions that hinder the overall implementation of the scholarship program.
3. The occurrence of natural disasters or non-natural disasters.
4. Other emergency circumstances as determined jointly by Indonesian AID and UIII.
5. INSANI's Awardee withdraws before the end of the study period.
6. INSANI's Awardee violates applicable laws and regulations, including the provisions set out in the Personal Statement/Student Agreement, resulting in the obligation to return to his or her home country.

F. MONITORING AND EVALUTAION

- a. Monitoring and evaluation of the implementation of the scholarship program shall be conducted by the Dean.
- b. Monitoring shall be conducted to observe and assess the academic progress of INSANI's Awardee.
- c. The results of monitoring are used as a consideration for evaluation to determine the continuation or termination of the scholarship for the awardee.

CHAPTER V

CONCLUSION

The Booklet for the INSANI Scholarship for the 2026 Academic Year are hereby promulgated to serve as the definitive framework for program implementation. These guidelines are designed to ensure that all administrative processes are executed with the highest standards of order, efficiency, transparency, and accountability. It is intended that this document provides all stakeholders with a rigorous and systematic comprehension of the scholarship's procedural requirements, eligibility criteria, and governing mechanisms.

Furthermore, it is anticipated that these guidelines will serve as a vital instrument in advancing equitable access to higher education, while concurrently cultivating academic excellence and scholarly distinction among all recipients.

PERSONAL STATEMENT

INDONESIAN AID SCHOLARSHIP FOR ISLAMIC COMMUNITY DEVELOPMENT (INSANI) 2026

I confirm and declare that:

1. I understand that scholarship under the INSANI Program is administered under the Grant Agreement between the Government of Republic of Indonesia and recipient country (“hereinafter referred to as Scholarship Program”);
2. I agree to obey the laws and regulations of Republic of Indonesia, understand that the law of Republic of Indonesia will apply to any agreement between myself and the INSANI committee, and I will maintain an acceptable standard of conduct during the term of my scholarship, if offered;
3. I agree to make every effort to achieve satisfactory academic result in my study and meet the criteria set by the universities;
4. I confirm that I do not have any health issues including mental health issue, disabilities, family or financial burden which might prevent me from completing my study within the term of Scholarship Program;
5. I am willing to confirm that I am not pregnant at the time of scholarship application
6. I agree to the release of valid information in this application form and information relating to the Scholarship Program or study to relevant authorities to enable placement in an education institution, consideration for a Scholarship Program, collection of academic progress reports and results, and the ongoing administration and monitoring of Scholarship Program;
7. I agree to the exchange of information with Indonesian AID and authorities such as Immigration office or other relevant government agencies;
8. I have not been involved in felony of any kind and I have not been involved in political activities of any kind;
9. I agree to ensure my visa and passport are kept current for the duration of the Scholarship Program;
10. During the scholarship period, I agree to:
 - a. undertake only the approved course of study which is chosen in the selection process;
 - b. undertake the Scholarship Program full time relying on its terms and conditions.
 - c. attend all classes enrolled at all times barring verifiable hardships, the university/college reserves the right to seek independent verification of the hardship to monitor and assess, compliance with this obligation;
 - d. continue to be enrolled in the minimum course hours required by the university/ college during the semester;
 - e. maintain current Satisfactory Academic Progress (SAP) to ensure the completion of the study program;

- f. follow all rules and regulations of the university/college including registration and admission procedures, attendance to classes and general behavior;
11. During the period of the Scholarship Program, I agree that I shall not:
 - a. undertake any additional or alter to any different scholarship program;
 - b. make any changes to my course of study;
 - c. work part-time or full-time job during the scholarship period;
 - d. apply for permanent residency of any country including Indonesia;
 - e. seek for asylum in any country including Indonesia and will not apply for different scholarships;
 - f. marry/or be married to, engage/be engaged to a de facto person who holds or is eligible to hold Indonesian citizenship or permanent residency or with other scholarship recipients at any time; and/or
 - g. not bringing family members to Indonesia for the purpose of settling during my scholarship contract period
 - h. conduct any immorality acts based on the laws, regulations, and local culture of the Republic of Indonesia.
 12. I shall be willing to lose my awardee status and leave Indonesia if I violate these provisions as stated in point 9.
 13. I acknowledge that:
 - a. I am responsible for all costs that occur during my scholarship period that are not covered by the scholarship benefits;
 - b. I am responsible for how I budget any scholarship benefits I receive to pay my living expenses;
 - c. That the health insurance during the scholarship period may not cover all medical expenses, and that I am liable for any additional expenses incurred by me.
 14. I agree to obey the laws and regulations of the Republic of Indonesia and maintain an acceptable standard of conduct while in Indonesia and understand that the law of the Republic of Indonesia will apply to any agreement between myself and the Indonesian Government;
 15. I acknowledge my scholarship program will be terminated if I:
 - a. Withdraw or dismiss from INSANI Program (whether voluntarily or administratively);
 - b. Violate this declaration, and/or
 - c. unable to complete studies due to academic failures.
 16. I agree that the Indonesian Government and INSANI committee is not responsible for any of my actions during the term of the Scholarship Program;
 17. I will make known the Indonesian AID Scholarship support wherever applicable, including in any published diploma or thesis works as well as any other publications related to results of the scientific work during the term of my scholarship;
 18. I agree that I shall return directly to my home country within 30 days completion of my study

19. I commit to clearly acknowledge the Indonesian AID's contribution in all publications or in conjunction with activities for which the grant is used with the following statement: *"This project has been funded with support of the Indonesian AID on behalf of the Government of the Republic of Indonesia. This publication/communication reflects the view only of the author, and the Indonesian AID cannot be held responsible for any use which may be made of the information contained therein."*
20. I agree that every data management and research financed by this grant will be a subject of intellectual property belonging to the Government of Indonesia.

I declare that the information provided about and by me in this application is true, complete and correct to the best of my knowledge. I acknowledge that supplying false or misleading information is a serious offence under the Indonesian Crimes Law and will result in Indonesian AID withdrawing a scholarship, if offered.
